ORDINANCE ADOPTING OFFICIAL SEAL

ON THIS, the 12th day of October, 1971, the City Council of the City of Bynum, Texas, convened in regular session at the regular meeting place thereof, the meeting being open to the public and notice of said meeting, giving the date, place, and subject thereof, having been posted as prescribed by Article 6252-17, Section 3A, V.A.T.C.S., there being present and in attendance the following members, to wit:

Mayor Finch introduced a proposed ordinance, which was read in full. Alderman G.L. Niece made a motion that any rule requiring ordinances to be read more than one time or at more than one meeting be suspended. The motion was seconded by Alderman James Bratcher and carried by the following vote:

That the Mayor has obtained a seal for the City of Bynum, Texas, and the City Council of Bynum, Texas, hereby adopts said seal as the official seal of the City of Bynum, Texas, and the

City Secretary is hereby authorized to imprint said seal on this Ordinance and all Ordinances in conflict herewith are repealed to the extent of the conflict.
